

What to do when you get arrested? Your rights in jail.

**De Arrestgroup will by stand-by during this action,
On de Numbers:**

You are about to join an, which also will track the police, so take care of each other, and don't make it possible for the police to take people with them. If people get arrested and we can not stop them, see how the people look like, what happened, where are the people being arrested etc. And give that information to the arrestgroup. If arrest will occur it is good to know what your rights are:

- < You have the right to stay anonymous, although the police will tell you not. You have still the right to stay anonymous even after the new identification-law started!
- < **Never give a statement about yourself are about other people, keep your mouth shut!**
- < The police is obligated to tell you why and on the base of which law-article you are arrested.
- < When you get arrested the police has the right to keep you for 6 hours. When you get transported to jail you are being checked and all your personal belongings will be taken. (money, keys, etc.) If you decide to be anonymous, the police can keep you inside for another 6 hours to try to find out your name. The police have the right to take your fingerprints and to make photos. (The time between 24 o' clock and 9 o' clock does not count.)
- < If the police suspect you for minor violations they can only keep you inside for 6 till 12 hours They will probably tell you other things, but don't let yourself be intimidated by their story's
- < **If you are released, please contact the arrestgroup!!!!** The arrestgroup knows how many people were arrested and they want to know when people are free again. They can also advise you what you should do when you have to go to court.
- < The police can also decide to keep you inside for 3 days, that's called: in verzekeringstelling, when they suspect you from doing bigger violations and they want to investigate this. You have the right to ask for your own lawyer, but you have to ask it explicitly yourself! Do ask for your own lawyer, even if the police says you won't get your own lawyer, because you have the right to this!!!!
- < After 3 days if they want to keep you longer you will have to be led for a judge commissioner, he/she will decide whether you stay an extra 10 days or will be released. They can keep you after this 10 days for another 3 x 30 days.

Furthermore some other points:

- < You have the right to get vegetarian or vegan food and when necessary, medical treatment. The police will make this very hard to get, so stay demanding it!! Stick to your rights!
- < The police might take your rights not very seriously and try to make your stay very unpleasant.
- < Women can only be checked by policewomen and men only by policemen.
